

### AMENDMENTS TO THE BYLAWS

Now that we have been in operation for a few years, the current practices and Texas requirements indicates some changes to the bylaws are needed. The proposed amendments are located on page 4 and 5 of this issue.

Please bring a copy of the original bylaws, along with the amendments in this issue, for questions at the May Meeting. A copy may be found in the 2004 yearbook, or on the BAGS website. A very limited amount of original bylaw copies will be available at the May general meeting.

These six amendments will be read at the May 2004 general meeting, and there will be a question and answer period on the agenda. Voting on the amendments will occur at the June general meeting. Members choosing to Absentee vote must mail their ballot to BAGS no later than Tuesday, June 15th, in order to be counted. Members voting by mail can copy the ballot below, write in their name, circle their choice, and mail it to:

### 2004 BAGS PROPOSED BYLAW AMENDMENTS - Page 1

Amendment 1: Remove the membership classification of Student.

Specifically located in Article I Membership Section 3, this amendment will remove the line:

A. Student (any person attending school full time) \$10

Recommendation on how to vote on amendment
1: The Board of the Society recommends a vote in
favor of removing the classification of Student.
We do not have any student members and the
price of \$10 is too low to pay for the cost of
membership. If this amendment passes, a
student would have to join as either an individual
member or as part of a family membership.

Amendment 2: Require the President to submit a Texas Franchise Tax Public Information Report.

In Article IV DUTIES OF BOARD Section 2 President add the sentence:

"Upon installation of the new officers, the President shall submit a Texas Franchise Tax Public Information Report listing all of the newly-elected officers of the Society."

Recommendation on how to vote on amendment 2: The Board of the Society recommends a vote in favor of spelling out this duty for the President. The Texas Franchise Tax Public Information Report is required of all corporations (both non-profit and profit). The Report makes the persons holding office in a corporation public information. After the new officers are installed, the Report should be sent to the State as required by law.

Amendment 3: Require the Treasurer to submit a Texas Franchise Tax Report.

In Article IV DUTIES OF BOARD Section 7 Treasurer add the sentences:

"The Treasurer shall submit a Texas Franchise Tax Report to the state of Texas. This Report shall be based upon the information at the end of the Society's fiscal year which ends on August 31."

Recommendation of how to vote on amendment 3: The Board of the Society recommends a vote in favor of spelling out this duty for the Treasurer. When the yearly account for the Society is completed, the income information should be reported to the State.

Amendment 4: Remove the unnecessary use of "Director" and "at large" from the bylaws.

Part A in ARTICLE III ELECTIONS Section 1. TIMING OF ELECTIONS Change the sentences: "Officers and at large members of the Board serve at the will of the general membership and ... (the sentence continues)" to "Officers of the Board serve at the will of the general membership ... (the sentence continues)"

Change "Other officer and director positions require only that the nominee be a voting member of the Society." to "Other officer positions require only that the nominee be a voting member of the Society."

Change "The nominating committee shall present a slate of officers and Directors At Large to the Board ... (the sentence continues)" to "The nominating committee shall present a slate of nominees to the Board ... (the sentence continues)"

Change "The Board of Directors will present the slate of nominations for Officers and Directors for election ... (the sentence continues)" to "The Board of Directors will present the slate of nominations for Officers for election... (the sentence continues)"

Change "Installation of newly elected Officers and Directors will take place ... (the sentence continues)" to "Installation of newly elected Officers will take place ... (the sentence continues)"

### 2004 BAGS PROPOSED BYLAW AMENDMENTS - Page 2

Part B in ARTICLE V MEETINGS Section 2. Attendance

Change "Officers, Directors, and Standing Committee Chairmen have the responsibility to attend all meetings. An Officer, Director or Committee Chairman.... (the sentences continue)" to

"Officers and Standing Committee Chairmen have the responsibility to attend all meetings. An Officer or Committee Chairman ... (the sentences continue)"

Change "Failure of the Officer, Director or Committee Chairman ... (the sentence continues)" to "Failure of the Officer or Committee Chairman ... (the sentence continues)"

Part C in ARTICLE VI "DIRECTOR AND OFFICER SUCCESSION AND REPLACEMENT" change to "OFFICER SUCCESSION AND REPLACEMENT"

In ARTICLE VI Section 1 Resignations

Change "An Officer or Director who intends to resign their position ... (the sentence continues)" to "An Officer who intends to resign their position ... (the sentence continues)"

In ARTICLE VI Section 2 Filling Vacant Officer or Director positions change to "Filling Vacant Officer positions"

In ARTICLE VI Section 2 "Director At Large and other officer vacancies shall be filled for the unexpired term ... (the sentence continues)" to "Officer vacancies shall be filled for the unexpired term ... (the sentence continues)"

Recommendation on how to vote on amendment 4: Vote yes. The Board of the Society consists of elected Officers and appointed committee chairs. There are no "Directors". The bylaws should reflect the administrative structure.

Amendment 5: Change Membership card to name tag

In ARTICLE IV DUTIES OF THE BOARD Section 9. REGISTRAR

Change the second sentence "... provide each new member with a Membership card ..." to "... provide each new member with a name tag ...".

Recommendation on how to vote on amendment 5: Vote yes. The Society does not issue "Membership cards"; we do supply nametags to members.

Amendment 6 Start the election process earlier in the year.


In ARTICLE III ELECTIONS Section 1. TIMING OF ELECTIONS

Change "In May, the President shall appoint a nominating committee composed of.... (the sentence continues)" to "In March, the President shall appoint a nominating committee composed of ... (the sentence continues)"

Change "The nominating committee shall present a slate ... to the Board of Directors at their June meeting." to "The nominating committee shall present a slate ... to the Board of Directors at their May meeting."

Change "The general membership will vote on the nominations at the August general membership meeting." to "The general membership will vote on the nominations at the July general membership meeting."

Recommendation on how to vote on amendment 6: Vote yes. The members who served on the previous nominating committee felt the nomination process did not start soon enough.

The George Memorial Library is a very nice library. Our group visited it last summer, and everyone enjoyed the trip. The library's collection contains:

- Non-current government records and indexes for Austin, Brazoria, Fort Bend, Matagorda, Waller and Wharton counties
- A very nice Civil War Collection
- The 1930 Federal Censuses for Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, Missouri, Oklahoma, North Carolina, South Carolina, Tennessee, Texas Virginia, and West Virginia
- American Revolutionary War Pension and Bounty Land Warrant Application Files
- · Books from many Texas counties
- Books from other states
- DAR lineage books and indexes
- · Family histories
- Immigration records (passenger lists)
- Local histories for the southeastern U.S.
- Periodicals (genealogical, historical and family publications)
- · A special collection of the Czech Heritage Society of Texas
- Texas Bureau of Vital Statistics: birth and death indexes, and newspapers (Fort Bend County only, starting with 1911).

There are about half a dozen readers and a copier in the genealogy room of the George Memorial Library. Copies can be made from one of the readers, so bring some dimes because the machine doesn't give change.

A library trip to the Clayton Library remains scheduled for Tuesday, August 17, 2004.
