

How Do You Spell Your Name?

With the possibility of spelling Costello with the first letter "K", you would have more than 50 variations of this one name.

We can spell our own present-day names, but all of us should be aware that others could have had multiple spellings of their names. How and why does this happen? How can we use the many names to search for our ancestors? There are many spellings of a name for many reasons. Some reasons range from incorrect transcriptions to ignorance of the "correct" spelling. Another reason is that the spelling has changed over the years.

Here is what I recommend:

1.) Make a list of the variations of the names you are researching.

2.) When you are researching, make a mark to the right of each variation where you have found a match.

For example: If Doug found one birth record and one marriage record with the spelling "Costello" and one baptismal record with the spelling "Costela" then his page would look like this:

Today we often misinterpret the handwriting of the past. A common occurrence in older handwriting was the use of a character that looks like our "f" but is an "s". There are many books and articles about reading old handwriting available to us.

What about the story that your ancestor's name was changed when they came from overseas? Let me illustrate, we currently use the Latin alphabet. Many parts of the world use other writing forms. For example, Greece uses the Greek alphabet, Russia and parts of Eastern Europe use the Cyrillic alphabet. How is someone from Eastern Europe, Japan, China, India, etc., able to write his name in English? Someone had to either translate or transliterate the name. If your ancestor did not know how to write his name then someone else had to spell the name phonetically.

3.) Always search the variations where you have already found a record. So Doug would always search for "Costello" and "Costela". If you cannot locate a record, then search by using the other spellings.

What can we do about this? Keep a list of all of the variations of your research name. Douglas Wilson has developed this list in the search for his great-grandmother, Julia Costello, who came from County Galway in Ireland:

4.) If possible search by the Soundex - The code used in census records to index names by sound. "Smith, Smyth, Smythe", and other variations all have the same Soundex code. Doug has these Soundex codes for his names: C240

As the Soundex code has reduced the variations in the list of names down to two, this example shows the value of the Soundex coding of names.

There is also the possibility of spelling the above names with the first letter of "K". To sum up, there are more than 25 variations of this one name.

Go back to locations, libraries, and records that you have searched in the past where you have failed to find records. Use your list of spelling variations and try to find records with the different spellings. If you previously only searched for "Jim Smith", now you need to use your list of spelling variations and search again. One more important note: If you have a name that is common (Smith), you MUST search using other details, such as the year and locale. When you add up the many records containing common names and your many spelling variations, you could spend too much time on one search, so for common names, you must know other details.

You may know how to spell your name, but the chances are very good that there are records with other spellings. Prepare yourself!!

Historic Sandy Point Cemetery is located in Sandy Point, Texas, approximately two miles north of Rosharon, in Brazoria County. A Texas State Historical Marker stands beside FM 521 near the cemetery, which is on private property, approximately one-half mile from the road. The cemetery is the resting place for two of Stephen F. Austin's Old Three Hundred colonists in Texas; Francis Bingham and John W. Bradley. The land surrounding Sandy Point Cemetery was not on one of Brazoria County's many antebellum plantations, but was surrounded by five plantations. The Bingham plantation was located to the north, the Coffee plantation to the west, and the Compton, Smith, and Tankersley plantations to the south. Members of all these families were buried there.

William Jefferson Kyle (1803 – 1864) and Thomas Jefferson Coffee (1805 – 1858) were prominent local businessmen buried at Sandy Point with members of their families. Four Confederate soldiers were buried at Sandy Point: Aurelius J. Terry, Clinton Terry, J. Glassell Smith, and Harrison Tankersley. Aurelius Terry was also a veteran of the Mexican War. The Terrys were brothers of Col. Benjamin Franklin "Frank" Terry, organizer and leader of Terry's Texas Rangers. He was killed leading the Rangers during their first battle in 1861. The cemetery's historical marker and other sources claim that Col. Terry was temporarily buried at Sandy Point Cemetery before his remains were moved to Glenwood Cemetery in Houston. Convincing evidence, including published eyewitness accounts, states that Col. Terry was originally buried at his Oakland Plantation in the Sugar Land area. The Glenwood Cemetery records show that his remains were moved from Sugar Land to Houston in 1880.

Two formal surveys of Sandy Point Cemetery have been conducted, with the earliest dated 1948 by the Daughters of the American Revolution's Asa Underwood Chapter. In 1963, the Daughters of the Republic of Texas, Cradle of Texas Chapter, completed their own survey of the cemetery and published it with other Brazoria cemeteries in 1965. Due to many fallen trees and severe overgrowth, recent surveys were incomplete.

On June 13th, 1998, Alvin resident Cathy Nash met with the Brazoria County Historical Museum's director to report the cemetery's deplorable condition. The Museum's Cemetery Committee was formed that day, led by Nash, and dozens of dead trees were removed during workdays scheduled when weather permitted.

The cemetery was fenced, through funds provided by the Velasco Cemetery Association, an action necessary to prevent cattle from knocking tombstones over while using them as scratching posts. An elaborate brick mausoleum standing near the cemetery entrance was collapsing due to trees growing through

the bricks. Committee members met with Graham Luhn, a restoration architect, and Johnny Pollan, an archeological expert, to determine the best methods of restoring the building, dated from 1859. Work began on January 22, 2003 by committee members under the guidance of master bricklayer, Boot Ermis. More than one thousand man-hours went into the mausoleum project alone.

Many tombstones have been cleaned and reset, and photographs have been taken of the individual stones and family plots. Transcription errors in the earlier surveys were partially caused by duplicate markers and are still shown on several Internet websites. Attempts to get these errors corrected have been unsuccessful.

Sandy Point Cemetery was granted historical cemetery designation by the Texas Historical Commission in 2003, and a marker celebrating this status was dedicated on May 22, 2004. Nearly one hundred people attended the ceremony including thirty-two descendants and relatives of the Sandy Point residents buried in the cemetery. A brief history of the cemetery was presented as well as details about the mausoleum's restoration. A map of the cemetery was made available to attendees, showing the twenty- one plots and surnames of those buried in each one. There are eighty-eight known burials in Sandy Point Cemetery. The earliest existing tombstone is dated 1852, and the latest burial took place in 1996.

The restoration continues in 2005, now in its sixth year. I am currently researching the families buried there with help from the historical museum's family files, which are collections of family histories compiled throughout the years. Adding the census research and Brazoria County land and probate records, the histories of the land and people are coming together. 
