Kathryn Black Morrow is a working historian and researcher and a BAGS charter member. At the February 2007 BAGS general meeting, Kathryn presented examples of documents she reviewed and indexes she created as a result of a threeyear project for Texas Southern University to summarize and index a series of more than 200 original documents pertaining to the

slave trade in early Texas. BAGS members and quests enjoyed her enthusiastic and engaging presentation. Kathryn is back this month to share some of the personal stories she uncovered while researching, interviewing, and documenting the history of Ellington Field. In 2007, Kathryn published her research in a book titled Defender of America's Gulf Coast, A History of Ellington Field, Texas, 1917-2007. This presentation should be entertaining to anyone interested in aviation history, Texas history, military history, or local history. Copies of this book will be available at the January BAGS general meeting for purchase.

She established the company, Kathryn Morrow Research, to "provide research, writing, editing and indexing services for authors of historical papers, family histories, graduate theses, and books." Kathryn's specialty is United States history and genealogical research with an emphasis on Texas, Oklahoma, Native American, and African American history. ## **Message from the President**

As I sit here in my library/home office/computer/genealogy room and look around...I shudder. I see those boxes of records, piles of papers, books, loose pictures of great-great so-and-so, unanswered correspondence and know I need to get it all organized. Where to



begin? That is my one and only New Year's resolution: get genealogy records in order. Sounds ominously simple, but I'm sure we all know how daunting this endeavor really can be... especially after years of research has amassed a huge collection of paper.

Usually I am a very organized person, ascribing to "A place for everything and everything in its place." That adage does apply to the rest of my house, but the library has gone into overload. Coupled with boxes of BAGS quarterlies, surname databases, membership lists from 2001-2007, etc., it is actually quite frightening. Maybe it's time to put the house on the market? I digress.

Somehow I seemed to be more organized pre-computer days. Then, I would send off via U.S. mail to some courthouse or fellow-researcher about a record or piece of information I needed. I would place the response in a paper file on that particular ancestor/family. Now, today, I have e-mails galore on these same ancestors, good hints and clues on these same ancestors, and do I need a hard copy of each e-mail? (That's some of what is in all those piles.) Or is it enough to record the information in my genealogy program's database and be sure to cite the source? Or is it sufficient to keep the info "filed" on my hard drive? Sure makes for a giant volume of data in my e-mail program and is that good or bad?

One thing I do know about getting organized is to start with baby steps and to be ruthless. To make my 2008 New Year's resolution a reality, I plan to tackle one pile or one-half a pile (depending on how tall it is—and some of them are whoppers—10 or 12 inches high!) at a time, two times a week. # President's Message (continued from page 2)

I will put each piece of paper where it ultimately should be placed, at that time. Handle a piece of paper one time only--that is a "Rule to Live By". If it should go into the trash, do it then! If it should go into an existing paper file, put it there! If it should go into a not-yet-made paper file, type up the label, make the file, and put the piece of paper in the new file, then. Simple.

I know from past experiences that I have a tendency to get side-tracked, though, as I put things in their proper place. I'll start reading an e-mail, for example, that I received from a distant "new" cousin about James Alston Weems (our 3ggf) and get swept into "genealogy mode" instead of "cleanup mode" and start analyzing: "James and his family were in the 1860 Macon Co, TN Census; only his wife Nancy and their 5 ch were in the 1870 Wayne Co. IL Census; James and Nancy and the 2 youngest ch were in the 1880 Marion Co, IL Census. Where was James in 1870? He didn't die until 1908. We know he was a Tennessean who joined the Union Army in KY. And we know he deserted 20 Nov 1862 near Atlanta. Was he hiding out in 1870?" ...oops, wait, I'm supposed to be putting piles into files...how did I get in Atlanta?

With the help of divine intervention I force myself to turn off the analytical process. I keep a very large "Reminder" tablet nearby. When I come across good questions, points to be further researched, a letter that needs to be answered...I'll write that down on the tablet and move on to attacking the piles. If I discipline myself to keep focused, I will be successful. But it is a challenge. Ask me in January of 2009 how I'm doing.

# **Local Cemetery Transcriptions**

Spread the word to local and national researchers tracing family members that once lived in Galveston County area. Members from local genealogical societies including BAGS, Galveston, League City, and Texas City are busy photographing and documenting all of the cemeteries in Galveston County for the purpose of family history research. They have taken over 20,000 photographs and are searching cemetery and local records to generate information for unmarked graves. Access free of charge, a compiled list of cemeteries published on the Galveston County TXGenWeb website (www.rootsweb.com/~txgalves) under the "Cemeteries" link. When transcriptions or photos are available, the cemetery name in the list is represented as a hypertext link to another set of web pages. In the next few months, BAGS expects to begin publication of their work in the Mt Olivet Cemetery.

"Library Corner" highlights resources available at our local area libraries. Please contact the newsletter editor if you would like to share a specific local library resource that was particularly helpful to your research.

They Came In Ships: A Guide to Finding Your Immigrant Ancestor's Arrival Record, 3rd edition by John P. Colletta, Ph.D. published by Ancestry Publishing in 2002.

Dr. Colletta teaches at the National Archives and Smithsonian Institution, Institute of Genealogy and Historical Research (Birmingham, AL), and Salt Lake Institute of Genealogy (Salt Lake City, UT).

This book explains how to use the wealth of material available to locate a particular individual's arrival information. Learn how the diverse data on a passenger list can be interpreted to expand your knowledge of your family history. The provided bibliography reflects the current state of both traditional and electronic resources. Separate strategies and sample research scenarios are presented to locate arrival and ship information recorded prior to 1820, and that recorded since 1820. A Federal law in effect on January 1, 1820 required a Federal record of passengers arriving at U.S. ports from foreign countries at port of entry. "For a complete, state-by-state listing of ports and border-crossings stations, along with an account of the arrival records that exist for each one, the years the lists cover and their indexes, see chapter 2 of the Guide to Genealogical Research in the National Archives" (available at Clayton, George Memorial, Texas City, and Rosenberg libraries) or the National Archives on-line resource information at

http://www.archives.gov/genealogy/immigration/passenger-arrival.html. There is not a central depository for pre-1820 passenger lists so you may not find the original record. Specific bound works and indexes found in libraries and special collections are recommended to locate a printed version of the original record. For example, local newspapers in the port of call cities reported on vessels entering and departing the harbor. Anything news worthy would be printed, including weather conditions, threat of

contagious disease, tonnage, merchandise offloaded, and passengers disembarked. Library of Congress provides a list of on-line historic and current newspaper archive resources at http://www.loc.gov/rr/news/oltitles.html.

Going To Texas: Five Centuries of Texas

Maps presented by the Center for Texas

Studies at Texas Christian University,
published by TCU Press in 2007.

Spanning a time period from 1548 to 2006, sixty-four historic maps express the knowledge, traditions, politics, and economics of a specific time and place. The accompanying essays provide context and insight into the variety of reasons family members were drawn to Texas. This book raises the awareness of Texas maps located in the Museum of the Big Bend, Sul Ross University, and Yana and Mary Davis map collection. The Texas General Land Office is charged with maintaining over 35 million historic maps and documents spanning three centuries of Texas history. Plate 64 on page 113 is an image of the Great Military Map of Texas published by the Texas General Land Office in 2006 and available for purchase. This map features major fortification sites in Texas, and includes illustrations of significant military events dating from 1685 to 1916.

Compiled Service Records of Confederate
Soldiers Who Served in Organizations from
the State of Texas are available on microfilm
(NARA M323, description) at the George
Memorial Library, location listed on page 6
in the "2008 Genealogy Fair" article.

Use the available bound indexes to determine which microfilm reel to access. The service records typically contain (1) card abstracts of entries relating to the soldier as found in original muster rolls, returns, rosters, payrolls, appointment books, hospital registers, Union prison registers and rolls, parole rolls, and inspection reports; and (2) the originals of any papers relating solely to the particular soldier. Browse the bound indexes for other Civil War states to identify family members that served (their rank and unit), and surname spelling variants.

Christine Rose is a Certified Genealogist, Certified Genealogical Lecturer, and Fellow, American Society of Genealogists. Her lecturing experience includes national conferences (National Genealogical Society, Federation of Genealogical Societies), and many regional and local seminars including New York Genealogical and Biographical Society in New York City; seminars in Chicago, Illinois; San Francisco, California; and Long Island, New York. In addition, she served on the faculty of the Institute of Genealogical Research in Washington, D.C., and has been on the faculty as an instructor and a coordinator of Samford University's Institute of Historical and Genealogical Research since 1992. Christine was elected Fellow, American Society of Genealogists in 1988. This honor is bestowed by peers based on the quantity and quality of publications and is limited to only 50 at any one time. She has also been awarded the prestigious Donald Lines Jacobus award for two genealogies, and received top reviews for the book she co-authored, The Complete Idiot's Guide to Genealogy. She has authored more than 15 additional books, including Courthouse Research for Family Historians.

Christine is a past VP for the Federation of Genealogical Societies, past VP for the Association of Genealogical Societies, and is presently a trustee of the Board for Certification of Genealogists. She has been interviewed on CBS evening news (San Francisco, California), W.H.O. (Des Moines, Iowa), and others. She has also been the subject of extensive news articles in the Des Moines Register, the San Jose [California] Mercury-News, and others.
