Friday, May 30, 2008 at 6:00pm: Bruce Lockett presents "Civil War Shipwrecks in East Texas Rivers"

Bruce Lockett is director of the Texas Archaeology Study Association (TASA) and president of the Vidor Historical Society. TASA was formed in 1988 by several people interested in saving the treasures of Texas and documenting sites of historical value. Specifically, the group focuses on locating and investigating shipwrecks, Civil War and early plantation sites, and Atakapa Indians coastal villages and camp sites. Their work involves underwater marine archeology, forensic archeology and anthropology, and paleontology.

TASA located the *Dan*, a Confederate gunboat, and the *Ida Reese*, a Union merchant vessel, sunk in the Sabine River. The group has identified over 90 wreck sites on the Sabine River, 22 wreck sites on the Neches River, and 24 wreck sites on the Trinity River.

TASA has found over 7 village sites and over 200 camp sites of Atakapa Indians where hundreds of artifacts and arrowheads have been documented. The group has documented Civil War and

early plantation sites along the Sabine River on both the Louisiana and Texas sides and identified over 40 military installations along the Sabine River.

TASA is currently working on preserving two cannons at the

original Fort Sabine, excavating the steamboat Josiah Bell for identification as an 1863 Civil War vessel, and producing a book on the historical culture of the Atakapa Indians as the last of the mound builders in the United States.

For those of you who missed the meeting, 2nd Vice President. Claudia Grafton, selected a panel of six BAGS members to answer member questions submitted at the March meeting. Those on the panel were Doug Wilson, Melodey Hauch, Dick Warren, Neil Miserendino, Mary Martin, Loren Martin, and Alice Braud-Jones as moderator. Twenty-six questions were submitted. The answers to these questions will be published in the BAGS Newsletter starting with this issue.

Demolition Day: Breaking Down Those Brick Walls Questions & Answers

Question: I need someone who reads Latin to read baptismal certificates: it would also help if they could read Polish.

As a general answer to anyone needing help translating records from a foreign language?

Suggest using an online resource Translation Guide (www.translation-guide.com). Select the language to translate from and to, enter a word or phrase, and receive a translation.

Another resource is the genealogical key word lists published by the LDS Family History Library for different languages. Find these word lists at you local Family History Center or on the Family Search website (www.familysearch.org). On the website, select "Search" tab, select "Research Helps" link, select "Sorted by Subject" link, and then select the alphabet letter "L" for languages. Scroll down the list to the "Language and languages" section. There are genealogical word lists for both Latin and Polish languages. These lists can help you translate enough of the documents so that you can extract the important genealogical information.

Look for a translator in **classified ads** printed in genealogical magazines (e.g. Family Tree or Family Chronicle) or online at the Association of Professional Genealogists (www.apgen.org).

"Research Tips" on the website Unpuzzling Your Past with Emily Anne Croom (www.unpuzzling.com/tips.php) includes a research tip on how to deal with research "brick walls".

Question: What U. S. records are available for pre-1700?

Answer: Since the United States did not exist prior to 1700, any records produced would be local records. Records exist in the British Archives (a.k.a. Public Records Office www.nationalarchives.gov.uk). Some of these PRO records are available on film at Clayton Library for each of the British colonies.

The DAR Library in Washington D.C. is an outstanding resource for publications (www.dar.org/library).

Other recommended resources: (Clayton Library call number provided in parenthesis)

The Genealogical Encyclopedia of the Colonial Americas by Christina K. Schaefer (929.107207 S294) is a "complete digest for the records of all the countries of the Western Hemisphere"

Adventurers of Purse and Person by John Frederick Dorman (A244 VA) is the Bible of Virginia research, as is the series Cavaliers and **Pioneers** published by the Virginia Genealogical Society (N967 VA). (continued on page 4)

The Complete Book of Emigrants series by Peter Wilson Coldham (325.242 C688 USA) is also considered by experts to be exceptional reference material

Virginia Immigrants and Adventurers by Martha W. McCartney (M123 VA) is a biographical dictionary of immigrants to the U.S. and their locations between 1607 and 1635.

Virginia's Colonial Soldiers (975.5 B665 VA) and Revolutionary War Bounty Land Grants (973.3 B665 USA) are also excellent published resources.

Virginia Genealogical Society's Barbara Vines Little presents a week-long class at Samford University's Institute for Genealogical and Historical Research (www.samford.edu/schools/ighr).

The Jamestowne and Mayflower Societies are also excellent resources for pre-1700 records. Their databases include history on early pioneers of the area and their descendants. Dependent upon the location of the individual you are researching, records are found at various sources.

Spanish records for the area affected by the Louisiana Purchase are found in the collection known as "The Cuban Papers". They are written in Spanish and the Clayton Library has the largest collection outside of Madrid, Spain.

These are the records of the Spanish government during its inhabitance of the area and include land, government, civil and other transactions. They are named "The Cuban Papers" because when the Louisiana Purchase was transacted, the documentation of the Spanish government was sent to Cuba for protection and historical purposes.

Question: I can't find documentation on the Internet on county genealogical groups to document oral family history for ancestors who lived in Georgia (ca. 1800).

Answer: Georgia records are unlike most other states and are kept regionally rather than at one state archive. These resources may be of some assistance:

Casey Edward Greene, Head of Special Collections at the Rosenberg Library in Galveston, will present and review original sources including Galveston mortuary and interment records, cemetery records, and church records of note to genealogists. He will also review finding aids for locating pertinent information, including indexes to the local Galveston newspapers.

Question: How does one investigate records in Europe, primarily in Poland, Austria, Germany and Wales?

As a general answer to anyone researching ancestors in another country:

The **online resource** *Cyndi's List* (**www.cyndislist.com**) provides a wealth of information for countries on resources and records available for genealogical research.

The LDS Family History Library provides resource guides to jump start your research for specific countries. Access these guides at your local Family History Center or online at the Family Search website

(www.familysearch.org). On the website, select "Search" tab, select "Research Helps" link, then select the alphabet letter representing your country of interest. Scroll down the list looking for the research outline for your country.

Search the online LDS library catalog by "place" to discover the records the library holds for your place of interest, things such as church records and indexes, vital records and many more. The more you know about your ancestor and his place of origin the more successful you will be in extending your lines. Access the online LDS catalog (www.familysearch.org), select "Library" tab, select "Family History Library Catalog" link, and then select "Place Search" button. For example of a place search, enter place Preussen, enter part of Germany, receive a list of topics and descriptions of records (e.g. civil registration of births from 1875 to present, church records of christenings from 1875 to present, or marriage records 1500-present)

When searching an ancestor name on the Family Search website, the results may include records from the **International Genealogical Index (IGI)**. This index contains millions of records of births and marriages, but no deaths. Many of the records in this database were extracted from church or civil registers. In that case the name of the church or repository is usually given. With this information you can order the film copy at your local Family History

Center. You may find other members of the family from a careful search of the film.

Specific answer to the question:

Since the borders of Germany, Poland, and Austria have been redrawn several times in the past two hundred years, the same city may have several names. Geographical aids and research books are available at the Clayton Library for each of these countries. During the early 1800's Napoleon Bonaparte ordered all births, deaths and marriages be recorded by civil (government) authorities. Before that time, it was common for the churches to keep that information. This order spread throughout Europe. Many of those records have been photographed and placed on microfilm copies at the Family History Library. Those microfilm records can be checked out a month at a time to the local Family History Center. These civil records are available for Wales back to 1837. Before that time, the records are still available at the Family History Library but they are church parish records.

Use virtual walls to break down your brick wall.

Checkout the free online virtual surname wall provided by the Southern California Genealogical Society

(www.scgsgenealogy.com/SurnameWall.htm).

Connect with people researching the same surname. Postings provide surname, geographic area(s) in which they lived, or their migration path(s), and associated time period.

An announcement indicated Personal Ancestry File (PAF) genealogical software support may end but users will have several migration options available. Once the New FamilySearch (NFS) free software is fully available, PAF users can transfer their data to NFS. Or PAF users can purchase a commercial genealogy program, many of which are currently developing support for NFS. From *The Ancestry Insider* blog entry dated March 12, 2008.
