“A Harvey Girl or a Soiled Dove” tells the good and the bad of certain ladies' contributions to the Civil War effort, before the day of women's liberation and the available records of identification. Some served as spies, etc. Red light districts in Galveston and Harris counties are discussed, as well as the “reservation” story up in Waco. They are listed on the census under various terms.

Trevia Wooster Beverly is a native Texan, her interest in genealogy began with a ninth-grade English project. She is a member of the Association of Professional Genealogists and maintains an active membership in a number of archival, cemetery, historical, genealogical, library, museum, lineage, and preservation organizations. She lectures and conducts

A New Year's Resolution "Organize your research"

Congratulations if you already have your information digitized and entered into a computer program that organizes and prints reports concerning your family's information! No matter if you are computerized or not, there are several tools that should be used to help focus, clarify, summarize, and track progress of your research on specific people. These tools are the family group sheet, research question list, research log, surname list, and timeline. They can be maintained electronically (in a document or spreadsheet format) or handwritten. Keep a copy of each close by when you are researching.

Family Group Sheets

Start with a family group sheet to provide the names and vital dates of any already discovered members in a single-family unit. Citations to the sources where this information was originally found should be included for future reference. This sheet is a good summary of names, dates, and relationships to help verify new information is consistent with your known ancestor's history. It will also help facilitate looking for other family members using the cluster research method (i.e. by looking at extended family and friends). Genealogy software easily prints the family group sheet as one of the available reports.

Research Questions

Second, write down a specific list of who, when, why, where questions you want to answer or objectives you want to achieve concerning one or more people on a family group sheet. Consult this list each time you begin researching to stay focused. As you are reviewing records additional questions will surface. Continue to add questions or goals to this list as a way of recording them for future use. Depending on your preference, start a new list for each family unit, person, geographical location, or research location.

Research Logs

During your research, maintain a research log to track the resources you have already searched for a specific person, family, or geographic location. Log entries should include the name of the resource/book/record searched, location where the source was accessed (e.g. library, call #, drawer #, website, database name, URL), date they were

accessed, list search terms (e.g. surnames, place names), AND briefly document what was found or NOT found. Your research will inspire new search angles and resources. This log can also include sources you plan to search and the purpose of the search. Consult this log each time you begin researching, to determine where to begin and what records to avoid searching a second time. Some online record sources are continually updated. Those resources should be searched periodically. The log dates can help you set up a schedule for repetitive searches. The article "Logging On" by Lisa A. Alzo in *Family Tree Magazine*, issue January/February 2013, p. 24-27 talks about creating a log, storing it online as a *Google* document, and provides inspiration for using this information during research.

Surname Lists

During your research, write down the different spellings for surnames and given names, as they are uncovered. Printed record indexes will help you identify spelling variants. Use this list to search for each spelling variant in each record resource you access.

Timelines

As you research a person, single family, or family line, create a timeline that summarizes their life events. Timeline entries include the date and location of events such as birth, marriage, death, migration, immigration, military service, land ownership, newspaper articles, and will probate. Timelines can point out an inconsistency in a date or location such as a person appears in two locations at the same time or two dates are documented for the same event. A timeline can guide research by showing a migration pattern, identifying new geographical locations to search for records. Timelines show time gaps where more information is needed.

Forms Resources

The electronic spreadsheet is helpful to track questions, logs, name lists, and timelines. The entries can be prioritized, color coded, and sorted in different ways. A number of online resources provide free copies of family group sheet, questions list, and log that can be printed. For example, these forms are available in PDF format on *Ancestors*:

Emancipation Proclamation

150th Anniversary

Signed by President Abraham Lincoln on
January 1, 1863

This proclamation declared “that all persons held as slaves” within the rebellious states “are, and henceforward shall be free.” This exempted Union states and the Confederacy portions that were already under Northern control. The Proclamation announced the acceptance of black men into the Union Army and Navy. By the end of the war, almost 200,000 black soldiers and sailors had fought for the Union. The [13th Amendment](#) to the U.S. Constitution passed by the Congress on January 31, 1865 and ratified by the states on December 6, 1865 formally abolishing slavery in the United States. A Texas Connection:

[Listen](#) to a small portion of an interview recorded in 1961 with Charlie Smith who was then 119 years of age. In this audio clip, Smith describes his life while working on the Smith Ranch in Texas at age 21 in 1863 when the Emancipation Proclamation was signed. The complete oral interview is housed in the National Archives on a cassette tape. The description of the complete interview is interesting:

Smith indicates that he was 12 years old when he was put on a slave ship from Liberia to U.S. He says he was bought at an auction in New Orleans by Charles Smith, a wealthy Texas rancher, who gave him his name (Smith states his real name was Mitchell Watkins). Smith lived and worked as one of the family on the Smith Ranch in Texas near Galveston and Red River. The King Ranch of Texas is on the land that was once the Smith Ranch.

Smith, 21 years old when the Emancipation Proclamation was signed in 1863, went to Hollywood with Charles Smith's son, John.

There he appeared as the cowboy, "The Trigger Kid" in Western films.

Smith discusses obtaining his Social Security card at the age of 113; marrying three times; and his

views on money, lifestyles, religion, work, and his formula for a long life.

Microsoft Word and Word Perfect formats for these and other forms are available online on *Cyndi's List* under the category “Organizing Your Research » Printable Charts & Forms” ([click here](#)) and on *FamilySearch Wiki* “Research Forms” article ([click here](#)). Be careful using some of the record summarizing forms because you run the risk of creating an error each time you duplicate or transcribe primary record information.
