July Program Recap - Widow & Divorce Records

Thank you to Melissa Hayes for discussing tips on discovering clues to the existnaces of additional marriages from information found on common record resources. Remember divorces were common before 1900.

Ancestry.com

She mentioned the "U.S., Civil War and Later Wars Index to Remarried Widow Pension Applications, 1860-1934" collection available in *Ancestry.com* which consists of a card index to pension claims made by widows of veterans of the Civil War and later wars. The cards typically include the name of the claimant, name of the soldier, military unit, the widow's certificate number, date of the claim/filing, and remarks. Changes in Pension Regulation

Normally pensions were revoked when a deceased veteran's widow remarried, but a March 3, 1901, act allowed a widow who lost her pension to remarriage to start collecting a pension again if she were widowed again following the later marriage or in cases when the later marriage ended in a divorce that was not the widow's fault.

Beginning May 1, 1920, remarried widows of veterans who had served at least 90 days in the Civil War and were honorably discharged or died in service were eligible for a pension. In cases where the veteran served less than 90 days, if he died of a disability incurred in service, the widow would also qualify. The index cards of widows who filed under this statute typically marked have "Act of May 1, 1920" stamped in the remarks field.

Even if you don't think your ancestors met the criteria for a pension, collections like this one are worth consulting. Many widows were not familiar with the intricacies of obtaining a pension and may have applied anyway.

Next Steps

Just because an application is referenced in this index does not necessarily mean that the widow obtained a pension. Once you've located a widow in this collection, your next step should be to obtain the pension file. Because the claimant had to prove she met all of the requirements, pension files are typically very rich in family history details and will reveal whether the claim was approved or denied. Files can include 100 pages or more. Some pension files are available on www.Fold3.com. If you're unable to locate the pension file online, you can order a copy of the pension file from the National Archives and Records Administration (www.archives.gov). [However, check with the Clayton Library first]

FamilySearch.org

FamilySearch.org maintains a similar collection called "U.S., Remarried Widows Index to Pension Applications, 1887-1942" which consists of two card indexes to widows who had applied for a pension renewal. The first covers service between 1812-1860 and is NARA microfilm publication M1784. The second covers service in the Civil War and later and is NARA microfilm publication M1785. Both indexes are part of RG 15 Records of the Veterans Administration. The files are located at the National Archives. When browsing the list of all published collections within FamilySearch.org, the following widow pension collections are found:

Through your local public library, access *HeritageQuest* U.S. Serial Set. This is a portion of the Congressional record covering memorials, petitions, and private relief actions requested by individuals and groups. Petitions for divorce were handled at the Federal and State level. Search this set to find an ancestor requesting aid or assistance, reimbursement, or petitioning a political action (e.g. divorces, immigration, war aid reimbursement).

Congratulations to Melodey Hauch for Winning Historic Preservation Award!

BAGS member Melodey Hauch was just announced as co-winner of Galveston Historical Foundation's 2014 Sally B. Wallace Awards for historic preservation. The Magnolia Cemetery Research Project started in 2006 when Lanny Martin and Melodey Hauch first visited the cemetery. Using Lanny's photos of the tombstones, Melodey created a spreadsheet with around 100 burials. Over the years, the two researchers worked to add the names of persons buried in the cemetery using Texas death certificates online and newspaper obituaries. Their latest count is 582 burials with 444 unmarked graves. During the last two years Melodey expanded the spreadsheet into a book entitled *Here They Rest: Discovering Unmarked Burials* at Magnolia Cemetery of League City. The book includes a history of the land and the African-American community in the Dickinson-League City area where most of the deceased lived as well as sections on the extended family members Melodey was able to connect through her research. Another section contains information on the cemetery's 42 known military burials. The names of the parents and spouses of the deceased and their places of birth, death and residence were also included when available on death certificates. The book includes a full name index with over 1500 names, many photos of the people and their tombstones, and a map of the inscribed tombstones.

The 2014 awards will be presented at a reception on Saturday, August 23, from 4 pm- 6pm, at the 1861 Custom House (502 20th Street, Galveston, TX). Admission is \$15 per person or \$100 for a reserved table for eight (8). The reception will include a short program, light hors d'oeuvres, beer and wine. For more information or to make reservations to the awards ceremony and reception, contact Galveston Historical Foundation (GHF) headquarters at 409-765-7834.

The late Sally B. Wallace was one of the driving forces behind Galveston Island's preservation movement and a pivotal figure in saving the antebellum Ashton Villa from demolition. The awards given in her honor by GHF recognize outstanding projects and craftspeople involving the preservation, restoration, and enhancement of Galveston County's historic buildings and neighborhoods.

New Congressional Bill

While tracking the progress of her VA request for two WWI markers for veterans interred in Fairfiew Cemetery, Deborah Gammon spotted a new bill "Honor Those Who Served Act of 2014" introduced to Congress and now referred to the Committee on Veterans' Affairs for consideration. This bill requests an amendment to Title 38, United Stated Code, to expand who is eligible to request headstones or markers furnished by the Secretary of Veterans Affairs. The update would allow veterans service agencies, military researchers, historians or genealogists to request a free headstone or marker from the Department of Veterans Affairs for a veteran's grave. Beginning Genealogy & African-American Research – Two Sessions

Nick Cimino will provide instruction on how to begin researching your family's ancestry with an emphasis on African-American ancestors. The September session will work through a case study on how to use 19th and 20th Century census, vital records, and military records. The October session will cover African-American history and genealogy in Texas, sources for Texas vital records, and genealogy records of special value to African-Americans.

"Hearing Heritage: Oral History, Genealogy, and Local History" presented by Dr. Stephen Sloan

Saturday, September 6, 2014 from 10:00am to noon at Bayland Community Center located at 6400 Bissonnet, Houston (between Hillcroft and Beechnut). This presentation will offer tips and approaches on how to effectively use oral history to document the history of families and communities. Much of the discussion will focus on strategies of project design and interviewing. Dr. Sloan is an Associate Professor of History and Director of the Institute of Oral History at Baylor University. He specializes in United States Post 1945, Public History, Environmental History, and the history of the American West. Program sponsored by Houston Genealogical Forum (www.HGFTX.org). Come early for refreshments and socializing (9:00-10:00). Visitors are welcome. From 9:00 - 9:45am, Nick will lead a Special Interest Group discussing "African American History and Research in Texas." He will cover the history of slavery in Texas, record sources for African American genealogy and a case study of an African-American family tree. 3rd Annual Genealogy Symposium Featuring John Philip Colletta, Ph.D. Saturday, October 18, from 9:30am to 4:30pm

(Registration opens at 9:00am) in the Meeting Room at George Memorial Library located at 1001 Golfview in Richmond, TX.



Nationally known genealogist and lecturer John Philip Colletta, Ph.D., will share his knowledge, experience, and insight on a variety of topics designed to help family-history buffs explore different avenues of genealogical research.

The program is free and open to the public. Seating is limited, however, and reservations are required. To register online at the library's website (www.fortbend.lib.tx.us), click on "Calendar," select "George Memorial Library," and find the program. Participants may also register by calling the library's Local History and Genealogy Department at 281-341-2608.

The first lecture, "U.S. Passenger Arrival Records, 1820-1930s: Sources and Strategies for Challenging Cases," will begin at 9:30 am. Dr. Colletta will provide an overview of sources for finding arrival records of 19th- and 20th-century immigrants to America. He will also discuss a variety of alternative sources and methods for overcoming obstacles such as variant spellings of names, conflicting arrival dates, confusion of ship names, various ports of departure and arrival, and missing passenger manifests.

At 11:00 am, Dr. Colletta will present "U.S. Military Pension and Bounty Land Records, 1776-ca. 1916." Learn how military-pension and bounty-land files in the National Archives differ from military-service records. Dr. Colletta will discuss the basic information needed to start a search for an ancestor's file, and where to find that information. He will then outline a step-by-step procedure for locating, identifying, and retrieving a particular file, using resources such as websites, National Archives indexes, and other search tools.

The final lecture of the day, "Principles of Good Writing and Good Storytelling," will begin at 3:30 pm. This lecture will demonstrate how to take known information about an ancestor's life and combine it with details from the period to create an engaging true story that will hook a reader's interest. Specific examples will show how to incorporate archaic expressions and period quotations; utilize literary techniques to describe the setting, action, characters, and theme; and remain historically accurate by using qualifiers such as "probably," "perhaps," and "evidently."

Dr. Colletta has written a "murder-mystery-family-history" with details from his own family history -- Only a Few Bones: A True Account of the Rolling Fork Tragedy and Its Aftermath – which recounts the story of his great-great-grandfather, Joe Ring, who moved his family from Buffalo, NY, to Rolling Fork, MS, after the Civil War. When Ring's country store burned to the ground with five unfortunate victims sleeping upstairs, the incident was investigated as mass murder, robbery and arson.

The genealogy symposium is presented with the generous support of the Friends of George Memorial Library. Proceeds from the Friends of the Library book sales and annual membership dues help to underwrite the costs of special programming and various cultural and educational events at the library.
