


January Program Recap - Citizenship and Naturalization Records

Doryn Glenn is a delight and a wealth of knowledge on the availability and access to genealogical valued records filed and maintained by the county court. She explained the paper trail created when seeking citizenship and naturalization. Aancestors seeking citizenship needed to file a declaration of intention form, (optionally) certificate of arrival, a petition for citizenship form, and an oath of allegiance. These primary source documents can include the ancestor's home country and last residence, port of emigration and immigration, current residence, current family members, occupations, age, physical description, birth date, birth location, and signature. Before the Federal government took over, these forms were filed in State District Courts located in the county where they were living, not the port of entry. By law, the person had to wait almost two years after immigrating to file the first form. Then the second form would be filed roughly three years after the first. If the ancestors moved during the process, the first part of the paperwork could be filed in one county court and the second part could be filed in a different county court. In these cases, be prepared to search court records in several counties. Soldiers who were granted citizenship would file the same paperwork but the required wait time would be waived. Doryn brought several binders of original declarations and petition forms for us to view. Galveston County has digitized their records which span from 1850's to 1950's: declarations of intentions, petition for citizenship/naturalization, oath of allegiance, petition granted or denied, and index books. Search and view these records at the Immigration Records Portal on the Galveston County District Clerk website http://gcdcimmigrationrecords.galvestoncountytx.gov can search without an account. You must create a free account to preview the record. The preview image has a watermark across the center but you can still download or print. You can purchase a copy without the watermark for \$1.00 per image with a \$1.00 service fee per transaction. Unclear if you get a link to print or receive a hardcopy in the mail.

Here is an example of a preview image found on the site. From this document, we learn that Patrick Moore submitted his declaration of intention for citizenship on February 6, 1931. At that time, he was age 40, not married, no children, and working as a ship's carpenter. He was 5(? covered by watermark) feet 8 inches, 165 pounds, with a light ruddy completion, no visible tattoos or scars, blue eyes, and light brown hair. He

emigrated from Liverpool England on the SS Issaic to Galveston, Texas arriving on January 5, 1921. He was Irish, born in Termonfeckin, Louth Co., Ireland on January 1, 1891.

By finding this record, we now could look for Patrick and his family in Termonfeckin, Louth Co, Ireland.

Clayton Library's microprint collection includes early naturalization records and indexes for counties in Texas and a number of other US States. The collection also includes records for WWI soldiers that were naturalized. A number of these record groups are also available through FamilySearch.org and Ancestry.com.

Local Family Photo and Document Digitization Resources

Clayton Library and Clear Lake City-Freeman Branch Library offer free resources to the community to create digital images of family memorabilia.

At the Clayton Library you can access the following equipment to preserve your family photo and documents:

- → A Kodak EZ Photo Scanner, a device capable of high-quality bulk photo scanning at the rate of 25 photos per minute for photograph preservation.
- → A flatbed photo scanner for photographs and documents that cannot or should not be put through the bulk photo scanner.
- * Kodak SlideSnap Lite, a quick and easy way to convert photographic images found on slides into digital images.



To use this equipment, call the Clayton Library at 832-393-2600 to make a reservation and bring a flash drive to save your new digital images. The library is located at 5300 Caroline Street, Houston.

At the Clear Lake City-County Freeman Branch Library in their Jocelyn H. Lee Digital Media Lab, you have the opportunity to scan photos, slides and documents; convert old video and audio formats to digital; and create and edit audio, music, images, and videos. The lab includes this equipment:

To use the equipment, you must call the library at 832-927-5420 to make a reservation after completing a brief orientation class which is offered several times each month. The library is located at 16616 Diana Lane, Houston, TX 77062
